

Dear User,

In accordance with art. 13 of Regulation (EU) 2016/679 (hereinafter, "GDPR"), please note that the processing of the data provided by you will be executed with methods and procedures which aim to guarantee that personal data is processed in a manner which respects the fundamental rights and freedoms, as well as the dignity of the data subject, with particular reference to the confidentiality and security, personal identity and the right to the protection of personal data.

We remind you that processing means any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction (art. 4 GDPR).

1 What cookies are

Cookies are small text file sent to the user by the website visited. They are saved on the computer's hard disk, thereby allowing the website to recognise the users and to save certain information about them, in order to permit or improve the service offered.

There are various types of cookies. Some are required to be able to browse in the Site, while other have various purposes such as guaranteeing internal security, administering the system, carrying out statistical analysis, understanding the Site sections which most interest users or offering customised Site visits.

The Site uses technical cookies and not profiling cookies. The above refers to both the user's computer and every other device the user may use to connect to the Site.

Technical cookies

Technical cookies are those used for the sole purpose of executing the transmission of a communication on an electronic communications network, or to the extent strictly required by the provider of an information company service explicitly requested by the subscriber or user to provide this service.

They are not used for further purposes and are normally installed directly by the website controller or operator.

They may be subdivided into browsing or session cookies, which guarantee normal browsing and use of the website (permitting, for example, purchases or authentication for access to reserved areas); analytics cookies, similar to technical cookies as they are used directly by the site operator to collect information, in aggregate form, about the number of users and how they visit the site itself; functionality cookies, which allow users to browse in accordance with a series of criteria selected (e.g. the language, the products selected for purchase) to improve the service provided to users.

Profiling cookies

Profiling cookies aim to create user profiles and are used to send ads in line with the preferences revealed by users as they browse the internet.

Use of profiling cookies requires the consent of the data subject. In accordance with Resolution no. 229 of 8 May 2014, users must be able to authorise or refuse consent for the installation of profiling cookies if they are present.

In the case of third-party cookies, the site does not have direct control over the individual cookies and may not control them (it cannot either install them directly or delete them). It is, in any case, possible to manage these cookies through the browser settings (follow the instructions provided below), or the sites indicated in the "Handling cookie" section.

Disabling cookies might restrict the possibility of using the Site and impede full enjoyment of the Site functionality and services. To decide which to accept and which to refuse, a description of the cookies used within the Site follows.

2 Types of cookies used

Session cookies

So-called 'session cookies' are saved temporarily and are deleted when the user closes the browser. If users register with the Site, they may use cookies which collect personal data in order to identify users at the time of subsequent visits and to facilitate Site access - login (e.g. by storing the user's username and password) and browsing. In addition, ECA Italia s.r.l. uses the cookies for system administration purposes. The Site might contain links to other sites. ECA Italia s.r.l. does not have any access to or control over cookies, web beacons and other tracking technologies used on the third party sites the user might access from the Site, the availability, any content and material which is published or obtained through these sites and their personal data processing methods; with regard to this, ECA Italia s.r.l., considering the large number of such third party sites, expressly declines all related responsibility. Users can check the privacy policy of the third party sites they access from the Site to learn about the conditions applicable to the personal data processing because the ECA Italia s.r.l. Privacy Policy only applies to the Site as defined above.
